BASIS, RATES, AND BILLING

DUES ASSESSMENT of Industry Consumer members is based on the consumption of all wood fiber and woody biomass as it enters the member's company manufacturing processes for the preceding calendar year. Consumption is reported in January of each year in green short (2000-pound) tons.

RATES for Industry Consumer members consuming wood fiber are based on a sliding scale applied as follows:

Dues Assessment Rates

Annual Dues Rate	Annual Wood Fiber and Woody Biomass Consumption In 2,000-pound "short" tons
1.493¢/ton	for the first 3,000,000 green tons
1.063¢/ton	for excess over 3,000,000 up to 5,000,000 tons
0.840¢/ton	for excess over 5,000,000 up to 10,000,000 tons
0.179¢/ton	for excess over 10,000,000 tons

Please report data in short (2000-pound) green tons. Please include all wood fiber and woody biomass at all company mill locations as it enters the member company manufacturing process for the previous calendar year, including roundwood and all chips and residuals, including woody biomass, purchased from outside sources. Do not recount wood purchased previously and transferred to another plant. Minimum dues for Industry Consumers is \$500.

**Annual Wood Consumption
(green tons)**

Pulping Process – All roundwood, chips, residuals, slabs, edgings, cores, shavings, bark, sawdust, etc. destined for a pulp and/or papermaking process.

Solid Wood – All roundwood destined for solid wood products (boards, ties, pilings, lumber, poles, etc.)

Manufactured Wood – All roundwood, chips residuals, slabs, edgings, cores, shavings, bark, sawdust, etc. destined for manufactured solid wood products (oriented strand board/OSB, flake board, particle board, hard board, plywood, composite siding, laminated beams, etc.)

Fuel Wood – All roundwood, chips, residuals, slabs, edgings, cores, shavings, bark, sawdust, etc. destined for fuel (co-generation, power boilers, steam boilers, heating boilers, biofuel production, etc.)

BILLING PROCEDURE - Assessments are payable in advance and are billed quarterly on May 1, August 1, November 1, and February 1.
